NPC Biennial Delegate Conference 2024



NPC holds a policy conference every two years. This year it was held in the Yarnfield Conference Centre in Stone, Staffordshire. NPC Wales sent 4 delegates, and they were the officers of NPC Wales: Chair Dereck Roberts Vice Chair Gareth Parsons Secretary Louisa St Bartholomew Brown-Morgan and Treasurer Melvina Richards.

There were motions on existing policy covering:

The Better Bus Campaign

The NHS with a focus on training for health care staff.

Pensions and income tax thresholds.

The conference passed a motion opposing Clause 128 and Schedule 11 of the Data Protection and Digital Information Bill. The clause **empowers the Secretary of State to require banks and financial organisations to provide data about bank accounts linked to benefit claimants including recipients of the state pension** via an "account information notice".

Climate Change and Older People. NPC says: We need a policy re-think in the UK. The impacts of climate change and extreme weather events can affect anyone, but there is conclusive evidence that when compared to other adults, older people - those over 65, but particularly people over 75 face more severe impacts as a result of flooding and heatwaves.

The United Nations (UN) Decade of Healthy Ageing: a global collaboration led by World Health Organisation (WHO) has confirmed **the next 10 years will be critical for the agendas of both climate change and healthy ageing.**

The current Commissioner for Wales' term of office ends in August 2024.

NPC Wales want to thank Helena for her work and support and wish her well for the future.

Welsh Government have started the process to **appoint the next OPCW** who will serve for a seven-year term of office. That will take place during

January – April 2024.

NPC Wales are involved in

that process. Chair Dereck Roberts and Secretary Louisa St Bartholomew-Brown Morgan have been appointed, by Welsh Government, to the Older People's Interview Panel. The panel will interview candidates to be appointed as the new OPCW.

They will then be interviewed by a Senedd All Party panel who will recommend an appointee.

The final decision and formal sign off will be made by the First Minister Vaughan Gething.

Google: Access Denied: Older people's experiences of digital exclusion in

Wales Increased use of digital technology puts older people at risk of social exclusion.

• Digital exclusion is central to discussions relating to the design and delivery of services.

• The voices of older people who are not online or who have limited digital skills are heard and responded to.

• Further practical action is needed to ensure the availability of non-digital information and services in community spaces, and to support older people to get and stay online if they wish to and do so securely and confidently.

The Commissioner is calling for action within the private sector focused on ensuring that:

• Customers who are not online receive equivalent levels of service to those who are.

• Approaches to digitalisation fully meet regulatory guidance on protecting vulnerable customers. • Additional support is provided to customers who are digitally excluded, or find themselves in vulnerable situations, including support with costs.

BT announces regional rollout schedule for Digital Voice in Wales :Spring **2024** BT's Digital Voice Advisory Group is an assembly of charities and representative groups brought together by BT to better understand how the transition to Digital Voice will affect different customers. This group plays a crucial role in shaping the rollout of BT's new home phone service, Digital Voice, which is being introduced to UK customers on a region-by-region basis. NPC and Age UK are members for that group.

BT Openreach are holding Engagement events throughout April as part of the rollout.

They will have a team on hand who can tell you what Digital Voice is, why the change is necessary, and what it means for you.

You don't have to pre-book, just turn up.

Also people need to be aware of scams as rogue traders may well try and con people into paying for the switchover – you don't it is paid for by the telephone service provider BT, Virgin Media, Talk Talk etc.

Lasting Power of Attorney (LPA's)

The Office of the Public Guardian (OPG) are currently running the Your Voice Your Decision Campaign (YVYD). Google:

Your voice, your decision – If you lose the ability to make certain decisions for yourself, a lasting power of attorney (LPA) lets people you trust quickly, easily, and legally step in.

A lasting power of attorney, or an LPA, makes it easier for the people you trust to support you when you need it most. It could be temporary help with your decisions during a short hospital stay, or support to manage decisions around your health and care in the longerterm.

Talk to someone you trust If you think making an LPA is right for you, talk to someone you trust today about creating one.

Make a lasting power of attorney

You can make a lasting power of attorney (LPA) online or using paper forms.

Either way, you need to get other people to sign the forms, including the attorneys and witnesses.

You can get someone else to use the online service or fill in the paper forms for you, for example a family member, friend, or solicitor.

It costs £82 to register an LPA unless you get a reduction or exemption.

You can cancel your LPA if you no longer need it or want to make a new one.



and the development of a fully **integrated Social Care service**, **free at the point of need**, as its first priority.


- The Cost-of-Living Crisis.
