

# Pensioners Manifesto 2024

### **Digital Inclusion**

The Older People's Commissioner for Wales reported in her 'Access Denied' report: "My findings highlight a stark digital divide that is not only exclusionary, but also often leaves older people feeling worthless, inadequate and that they are not valued by society."

#### That is unacceptable.

The next Westminster
Government should ensure that
all people aged 60 years or
older have access to broadband
internet at zero cost. They
should be provided with
suitable equipment and support
in order to be able to access
vital on-line services.

For those older people who cannot access online services, or do not wish to go on line, government must enshrine, in law, that non-digital options remain available and accessible for both the Public and Private Sectors.

### **Barnett must go**

In November 2023, the Westminster Government issued version 10 of the Barnett Formula. There is significant underfunding of services in Wales.

NPC Wales calls upon the next Westminster Government to reform the Barnett formula and make it one that takes account of the relative socio-economic needs in Wales, Scotland, Northern Ireland, and regions of England.

Decisions on how it is applied should be made in open consultation with the devolved administrations and the regions of England rather than unilaterally by the UK Treasury. The Treasury should publish its funding calculations in a single, coherent, and consistent publication.

### **Health and Care**

NPC Wales supports one system of seamless health and care for Wales and the UK - free at the point of need.

## Free TV Licences for the over 75s and the future of the BBC

As the world appears to be growing even more dangerous and misinformation explodes the public service ethos of the BBC to inform, entertain and educate is something that we should fiercely protect and fund properly.

## Climate Change, Fuel Poverty, Energy, Housing and Environment

### Transport Sort out the buses!

concession card for all those

which a moderate fee is
payable, which enables them to
purchase all UK wide rail and
coach fares with a 30%
discount.

### **Decent state pensions and Universal Benefits**

The basic state pension should be set at 70% of the living wage (outside London rate) and above the official poverty level.

Every year the state pension (basic and second such as State Earnings Related Pension Scheme SERPS) should rise in line with the best of earnings, the Consumer Price Index, the Retail Price Index or 2.5%. The Income Tax Personal Earnings Allowance for those in receipt of the state pension should increase, annually, with the level of inflation.

#### **Universal Pensioner Benefits**

Until we get a decent state pension, NPC Wales supports the maintenance of universal pensioner benefits such as free bus travel and a £500 winter fuel allowance.

### **Public Toilets**

The provision of publicly owned toilets should be made a statutory responsibility for all local authorities in England and Wales and funding for them should be included in the Local Authority Revenue Support Grant.
